

**Whirlpool Corp. 115th Anniversary Sweepstakes
Official Rules**

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES AND THE DECISIONS OF THE SPONSOR, WHICH ARE FINAL AND BINDING IN ALL RESPECTS, SO PLEASE READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THESE OFFICIAL RULES INCLUDE YOUR OBLIGATION TO INDEMNIFY THE SWEEPSTAKES PARTIES AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The Whirlpool Corp. 115th Anniversary Sweepstakes (the "Sweepstakes") is open only to legal residents of the forty-eight (48) contiguous United States and the District of Columbia who are eighteen (18) years of age or older at the time of entry. Employees, officers and directors of Whirlpool Corporation ("Sponsor"), Ketchum Inc., Realtime Media LLC ("Administrator"), and their respective parent companies, affiliates, subsidiaries, advertising, promotion, fulfillment and marketing agencies (collectively, the "Sweepstakes Parties"), and each of their immediate family members and those living in the same household of each (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. For purposes of this Sweepstakes, "immediate family members" are defined as spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses, regardless of where they reside, and "those living in the same household" shall mean people who share the same residence at least three (3) months a year, whether legally related or not. Void in Alaska, Hawaii, and where prohibited by law. All applicable federal, state and local laws and regulations apply. By participating in the Sweepstakes, entrants unconditionally accept and agree to comply with and abide by these Official Rules and the decisions of the Sponsor, including the interpretation of these Official Rules, administration of the Sweepstakes, selection of the winners, and the Sponsor's exercise of discretion, which shall be final, non-appealable, and binding in all respects.
2. **TIMING:** The Sweepstakes begins at 12:00:00 p.m. Eastern Time ("ET") on August 20, 2026 and ends at 11:59:59 p.m. ET on September 27, 2026 (the "Sweepstakes Period"). The designated computer clock of the Administrator is the official time-keeping device for the Sweepstakes.
3. **HOW TO ENTER THE SWEEPSTAKES:** During the Sweepstakes Period, visit www.whirlpoolcorp115sweeps.com (the "Website") and follow the on-screen instructions to complete the registration form. After registering (or logging in if you have previously registered), upload an original photograph that clearly depicts a Whirlpool®, KitchenAid®, Maytag®, Amana®, Roper®, or other branded product manufactured by Sponsor and submit an accompanying caption of no more than three hundred (300) characters describing your memory, experience, or story related to the Whirlpool®, KitchenAid®, Maytag®, Amana®, Roper®, or other branded product manufactured by Sponsor shown in the photograph (collectively, a "Submission"). Submissions must comply with the Submission Requirements in Section 5 to be eligible. Upon successful submission of an eligible Submission in accordance with these Official Rules, you will receive one (1) entry into the Sweepstakes Submissions may, in Sponsor's sole discretion, be displayed in a gallery on the Website; however, inclusion in the gallery is not required for participation in the Sweepstakes or to be eligible to win, and does not represent a determination that the Submission

is eligible or complies with these Official Rules.

For purposes of this Sweepstakes, an "Entry" is defined as one (1) eligible Submission received by Sponsor in accordance with these Official Rules. Entries must be successfully submitted through the Website during the Sweepstakes Period. Entries will not be judged (other than confirming eligibility of potentially winning Entries based on the Submission Requirements and these Official Rules) and will therefore not increase or decrease an entrant's chances of winning a prize. Entries not actually received by Sponsor will not be entered into the Sweepstakes. Entries are subject to the limits set forth below.

4. **ENTRY LIMITS:** Limit one (1) Entry per person and per email address during the Sweepstakes Period. Subsequent attempts made by the same individual to submit multiple Entries by using multiple or false contact information, email addresses, accounts, identities or otherwise may result in the entrant being disqualified, all associated Entries being declared void, and any prize won being forfeited. Each Entry must be manually completed and submitted by the individual entrant. Entries generated by script, computer program, macro, programmed, robotic or other automated means are void and will be disqualified. Entries that exceed the stated limit, are incomplete, illegible, corrupted, damaged, destroyed, forged, false, lost, late, misdirected, deceptive, or otherwise fail to comply with these Official Rules may be disqualified in Sponsor's sole and absolute discretion. Entries submitted by persons who do not meet the eligibility requirements are void. In the event of a dispute regarding the identity of an entrant, the Entry will be deemed submitted by the authorized account holder of the email address used to register for the Sweepstakes, provided such person is otherwise eligible. The "authorized account holder" is the natural person assigned to the applicable email address by an Internet access provider, online service provider, or other organization responsible for assigning email addresses. Sponsor may require proof that a potential winner is the authorized account holder of the email address associated with the winning Entry. If a dispute cannot be resolved to Sponsor's satisfaction, the affected Entry will be deemed ineligible.
5. **SUBMISSION REQUIREMENTS:** To be eligible, Submission must be the entrant's original work and must not:
 - contain material that is unlawful, defamatory, libelous, obscene, offensive, hateful, threatening, harassing, or otherwise inappropriate;
 - depict or promote illegal activity, violence, dangerous or inappropriate conduct;
 - contain material developed by AI;
 - contain or depict alcohol, tobacco, cannabis, firearms, illegal drugs, or other controlled substances (if prohibited by the campaign);
 - contain nudity or sexually explicit or suggestive content;
 - infringe or violate the intellectual property, privacy, publicity, or other rights of any third party;
 - contain trademarks, logos, copyrighted works, or other proprietary materials owned by others (except those owned by Sponsor, if permitted);
 - identify or depict any person who has not granted permission to appear in the Submission (to the extent such permission is necessary for display or use of the Submission as set forth in these Official Rules, or any minor without the permission of the minor's parent or legal guardian);
 - contain false, misleading, or disparaging content or statements about Sponsor or any other person or entity; or
 - otherwise violate these Official Rules or applicable law.

Sponsor reserves the right, in its sole discretion, to review, moderate, reject, remove, or disqualify any Submission that it determines does not comply with these Official Rules or is otherwise inconsistent with the spirit or theme of the Sweepstakes.

6. **SUBMISSION LICENSE AND REPRESENTATIONS:** By submitting a Submission, entrant grants the Sweepstakes Parties a non-exclusive, worldwide, royalty-free, perpetual, irrevocable license (with the unlimited right to sublicense) to use, reproduce, modify, adapt, publish, create derivative

works from, distribute, display, and otherwise exploit the Submission, together with entrant's name, likeness, and other information, and that of any other person included in the Submission, for any lawful purpose, including advertising, promotional, and commercial purposes, in any media now known or hereafter developed, without further notice or compensation except where prohibited by law. Entrant represents and warrants that the Submission is entrant's original work and does not infringe, misappropriate, or otherwise violate the rights of any person or third party, including any intellectual property, privacy, publicity, or other proprietary rights.

7. **SWEEPSTAKES DRAWING:** On or about September 28, 2026, the Administrator will conduct a random drawing from among all eligible Entries received during the Sweepstakes Period to select one hundred fifteen (115) potential winners. The odds of winning depend on the total number of eligible Entries received. Sponsor's decisions regarding the administration of the Sweepstakes, interpretation of these Official Rules, selection of winners and determinations of eligibility and compliance with these Official Rules are final and binding in all matters relating to the Sweepstakes.
8. **ODDS:** The odds of winning a prize depend on the total number of eligible Entries received during the Sweepstakes Period.
9. **WINNER NOTIFICATION/PRIZE CLAIMING:** Potential winners will be notified by email using the email address provided at the time of entry in a commercially reasonable time following the drawing. The Sweepstakes Parties are not responsible for false, incorrect, changed, incomplete, or illegible contact information, or for electronic communications that are undeliverable due to filtering, insufficient mailbox capacity, or any other reason beyond the Sweepstakes Parties' reasonable control. Potential winners will have three (3) calendar days from the date the notification is sent to respond and complete and return the Prize Redemption Form, Declaration of Eligibility, Liability Release, Publicity Release (where lawful), and any requested information necessary for prize fulfillment, including personal information required for tax reporting purposes, if applicable, as a condition of receiving a prize. If a potential winner fails to respond within the required time period, fails to timely complete or return the Redemption Form, the notification or Redemption Form is returned as undeliverable, or the potential winner is otherwise determined to be ineligible or not in compliance with these Official Rules, the potential winner may be disqualified and an alternate potential winner may be selected, time permitting, in Sponsor's sole discretion. Upon prize forfeiture, no compensation will be given.

The Sweepstakes Parties are not responsible for and shall not be liable for late, lost, damaged, intercepted, misdirected, or unsuccessful efforts to notify the potential winners.

Five (5) Maytag® Smart Front Load Washer with Pet Pro Option, 5.0 cu. ft. Prizes: Each winner will receive one (1) Maytag® Smart Front Load Washer with Pet Pro Option, 5.0 cu. ft. Color and/or finish will be determined by Sponsor in its sole discretion. ARV: \$1299.00 each.

Five (5) Whirlpool® Third Rack Dishwasher with Advanced ProDry™ System Prizes: Each winner will receive one (1) Whirlpool® Third Rack Dishwasher with Advanced ProDry™ System. Color and/or finish will be determined by Sponsor in its sole discretion. ARV: \$1099.00 each.

Sponsor will arrange and pay for standard delivery, installation, and haul-away of an existing appliance, if applicable. Sponsor will not be responsible for any modifications, upgrades, or additional work required to complete installation, including, without limitation, electrical, plumbing, cabinetry, flooring, ventilation, or gas line modifications, or any hookups, connections, permits, or other installation requirements not already present at the delivery location. The total ARV of all prizes is \$60,534.00. Prizes are non-assignable and non-transferable, with no cash redemptions, equivalents, or substitutions except at Sponsor's sole and absolute discretion. All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. Prize details and availability are subject to change and Sponsor's rules and restrictions, and in the event that Sponsor is unable to provide a winner with a prize, the Sponsor may elect to provide winner with the approximate value of such item in cash or award an alternate prize of comparable or greater value. Prizes are awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose), other than the standard manufacturer warranty. Prize winners will be solely responsible for all federal, state and/or local taxes, and for any other fees or costs associated with the prizes received, regardless of whether they, in whole or in part, are used. Such Advertising shall be solely under the control of Sponsor and/or its licensors, and each winner hereby waives any claim of control over the Advertising content as well

as any possible claims of misuse of such winning recipient's name, likeness or voice under contract, tort or any other theory of law. If the Sweepstakes is not capable of running as planned for any reason, including without limitation, due to the failure or interruption of any social media platform or any internet service provider, tampering, unauthorized intervention, fraud, or any other causes which corrupt or affect the administration, security, fairness, integrity, or proper conduct of the Sweepstakes, Sponsor reserves the right, in its sole discretion, to disqualify any individual who is responsible or who tampers with the entry process, and to cancel, modify, or terminate the Sweepstakes. In the event there is a discrepancy or inconsistency between disclosures and other statements contained in any Sweepstakes materials and the terms and conditions of these Official Rules, these Official Rules shall prevail, govern, and control. All decisions as to these Official Rules and interpretations thereof are exclusively within the sole discretion of the Sweepstakes Parties and may be changed from time to time without notice. In the event Sponsor is prevented from continuing with the Sweepstakes by any event beyond its control, including, but not limited to, fire, flood, epidemic, earthquake, explosion, labor dispute or strike, act of God or public enemy, communications or equipment failure, utility or service interruptions, riot or civil disturbance, terrorist threat or activity, war (declared or undeclared), interference with the Sweepstakes by any party, or any federal, state, or local government law, order, or regulation, order of any court or jurisdiction, or other cause not reasonably within Sponsor's control (each, a "Force Majeure" event or occurrence), Sponsor shall have the right to modify, suspend or terminate the Sweepstakes or prize without any further obligation. Sponsor additionally reserves the right, in its sole and absolute discretion: (a) to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes; or (b) to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Sweepstakes; (ii) acting in violation of these Official Rules; or (iii) acting in an un-sportsmanlike manner.

12. **CONDUCT:** By participating in the Sweepstakes, entrants agree to be bound by these Official Rules. Sponsor reserves the right, in its sole discretion, to disqualify any entrant who tampers with the entry process or the operation of the Sweepstakes, acts in violation of these Official Rules, or acts in an unsportsmanlike, disruptive, abusive, or otherwise inappropriate manner. **CAUTION:** ANY ATTEMPT BY ANY PERSON TO DELIBERATELY DAMAGE, TAMPER WITH, OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS. 13. **WAIVERS AND DISCLAIMERS:** The Sweepstakes Parties assume no responsibility or liability for: (a) lost, late, stolen, undelivered, inaccurate, incomplete, delayed, misdirected, damaged or garbled Entries, URLs, social notifications, or emails; (b) any incorrect or inaccurate Entry information, or for any faulty or failed electronic data transmissions; (c) any unauthorized access to, or theft, destruction or alteration of Entries at any point in the operation of this Sweepstakes; (d) any technical malfunction, failure, error, omission, interruption, deletion, defect, delay in operation or communications line failure, regardless of cause, with regard to any equipment, systems, networks, lines, cable, satellites, servers, computers or providers utilized in any aspect of the operation of the Sweepstakes; (e) inaccessibility or unavailability of the Internet, or any other associated website, or any combination thereof or for computer hardware or software malfunctions, failures or difficulties, or other errors or difficulties of any kind whether human, mechanical, electronic, computer, network, typographical, printing or otherwise relating to or in connection with the Sweepstakes, including, without limitation, errors or difficulties which may occur in connection with the administration of the Sweepstakes, the processing of Entries, social media posts, the announcement of the prizes, or in any other Sweepstakes-related materials; or (f) any injury or damage to entrants or to any other person's computer which may be related to or resulting from any attempt to participate in the Sweepstakes. If, for any reason, the Sweepstakes (or any part thereof) is not capable of running as planned for reasons which may include, without limitation, infection by computer virus, tampering, unauthorized intervention, fraud, technical failures, or any other causes which may corrupt or affect the administration, security, fairness, integrity or proper

conduct of this Sweepstakes, then the Sweepstakes Parties reserve the right at their sole discretion to cancel, terminate, modify or suspend the Sweepstakes in whole or in part. If terminated, the Sweepstakes Parties will award the prizes from among all non-suspect, eligible Entries received for the Sweepstakes up to the time of such action.

14. **RELEASES:** All entrants, as a condition of participation in this Sweepstakes, release, discharge, indemnify and hold harmless the Sweepstakes Parties, and each of their respective directors, officers, employees, agents, successors and assigns (collectively, "Released Parties") from and against any and all liability, claims, costs (including attorneys' fees and expenses), losses, damages, fines, or actions of any kind whatsoever for injuries, death, damages, or losses to persons or property which may be sustained, in whole or in part, directly or indirectly, in connection with: (i) participation in any aspect of the Sweepstakes (including travel to/from any Sweepstakes activity), (ii) the receipt, ownership, use or misuse of the prize awarded, including any travel associated with any prize, (iii) the Released Parties' violation of rights of publicity or privacy, claims of defamation or portrayal in a false light or based on any claim of infringement of intellectual property; (iv) entrant's Entry material on any related website, or (v) any typographical, human or other error in the printing, offering, selection, operation or announcement of any Sweepstakes activity and/or prize.
15. **GOVERNING LAW AND LIMITATION OF LIABILITY:** All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules or the rights and obligations of entrants, Sponsor or the Released Parties in connection with the Sweepstakes will be governed by and construed in accordance with the internal laws of the State of Michigan, without giving effect to any choice of law or conflict of law rules or provisions that would cause the application of any other laws.

BY ENTERING THE SWEEPSTAKES, ENTRANT AGREES THAT TO THE EXTENT PERMITTED BY APPLICABLE LAW: (A) ANY AND ALL DISPUTES, CLAIMS AND CAUSES OF ACTION ARISING OUT OF OR CONNECTED WITH THE SWEEPSTAKES, OR ANY PRIZE AWARDED, WILL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION; (B) ANY AND ALL CLAIMS, JUDGMENTS AND AWARDS WILL BE LIMITED TO ACTUAL THIRD-PARTY, OUT-OF-POCKET COSTS INCURRED (IF ANY) NOT TO EXCEED TEN DOLLARS (\$10.00), BUT IN NO EVENT WILL ATTORNEYS' FEES BE AWARDED OR RECOVERABLE; (C) UNDER NO CIRCUMSTANCES WILL ANY ENTRANT BE PERMITTED TO OBTAIN ANY AWARD FOR, AND ENTRANT HEREBY KNOWINGLY AND EXPRESSLY WAIVES ALL RIGHTS TO SEEK, PUNITIVE, INCIDENTAL, CONSEQUENTIAL OR SPECIAL DAMAGES, LOST PROFITS AND/OR ANY OTHER DAMAGES, OTHER THAN ACTUAL OUT OF POCKET EXPENSES NOT TO EXCEED TEN DOLLARS (\$10.00), AND/OR ANY RIGHTS TO HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED; AND (D) ENTRANTS' REMEDIES ARE LIMITED TO A CLAIM FOR MONEY DAMAGES (IF ANY) AND ENTRANT IRREVOCABLY WAIVES ANY RIGHT TO SEEK INJUNCTIVE OR EQUITABLE RELIEF. SOME JURISDICTIONS DO NOT ALLOW THE LIMITATIONS OR EXCLUSION OF LIABILITY, SO THE ABOVE MAY NOT APPLY TO YOU.

16. **DISPUTE RESOLUTION:** The parties each agree to finally settle all disputes only through arbitration; provided, however, the Sponsor shall be entitled to seek injunctive or equitable relief in the state and federal courts in the State of Michigan, and any other court with jurisdiction over the parties. In arbitration, there is no judge or jury, and review is limited. The arbitrator's decision and award is final and binding, with limited exceptions, and judgment on the award may be entered in any court with jurisdiction. The parties agree that, except as set forth above, any claim, suit, action or proceeding arising out of or relating to this Sweepstakes shall be resolved solely by binding arbitration before a sole arbitrator under the streamlined Arbitration Rules Procedures of JAMS Inc. ("JAMS") or any successor to JAMS. In the event JAMS is unwilling or unable to set a hearing date within fourteen (14) days of the filing of a "Demand for Arbitration", then either party can elect to have the arbitration administered by the American Arbitration Association ("AAA") or any other mutually agreeable arbitration administration service. If an in-person hearing is required, then it will take place in the State of Michigan. The federal or state law that applies to these Official Rules will also apply during the arbitration. Disputes will be arbitrated only on an individual basis and will not

be consolidated with any other proceedings that involve any claims or controversy of another party, including any class actions; provided, however, if for any reason any court or arbitrator holds that this restriction is unconscionable or unenforceable, then the agreement to arbitrate doesn't apply and the dispute must be brought in a court of competent jurisdiction in the State of Michigan.
